	This process entails analyzing mergers which require full notification, meaning notifications. This applies applications where the parties' combined annual turnover or assets (whichever is higher) is above Ksh.1 billion and that of the target undertaking is above Ksh.500 million. This is provided for in the Merger Threshold Guidelines under the Competition General Rules 2019.
	Upon analyzing the merger notification, the Competition Authority of Kenya commits to issuing a determination approving the merger conditionally, unconditionally or declining it within the statutory timelines of 60 days after receipt of relevant and complete information.


